Said customer owns property at _____ (Lighting location) and hereby requests the installation of the following High Pressure Sodium Outdoor Private Light(s) at this location.

This AGREEMENT is subject to the Rules and Regulations of Murfreesboro Electric Department. In accordance with Part B of Outdoor Lighting Rate Schedule LS, the total monthly outdoor lighting cost, without taxes, shall include monthly Kilowatthour usage times the cost per KWH plus monthly facility charges. **KWH charges and facility charges may change** from time to time during the term of this contract.

Murfreesboro Electric Department hereby agrees to provide, install, operate and maintain the above requested outdoor security lights on a truck accessible, existing MED pole in return for the customer's agreement to pay bills in a timely basis and the customer's agreeing to make every effort to protect the installation from damage.

The location of the light(s) having been mutually agreed upon, any relocation performed at the customer's request shall be made by MED at the customer's expense.

This AGREEMENT shall become effective upon completion of the installation(s) and shall continue in effect for an initial period of **FIVE (5) years**, and thereafter from month to month until terminated by either party. Should the customer request termination of the lighting service, for any reason, prior to the conclusion of the initial FIVE year contract period, customer will be obligated to pay monthly facilities charges for the remainder of the contract period at that time.

If a pole is not located where a security light is needed and this area is rock-free, truck accessible and has secondary service available, a pole will be installed for a one-time fee of \$ 400.00 or an additional monthly facility charge of \$ 8.20. If rock is encountered in the digging of the pole hole(s), then these added costs will be billed to the customer as a one-time additional installation fee.
